The Schedule of Items is amended as follows:

1. In Group 6, the bid item "Shear Connectors" is no longer required for this project and has been removed as a pay item.
2. In Group 10, the fixed unit price for the bid item "Barricade, Type II" has been removed. The Contractor will now be required to supply a bid price for this item.

The EBS generated bid items sheet must show these corrections or the bid will be considered void.

On page 57 of the Special Provisions, in the second paragraph of the provision titled COLD MILLING, CLASS 3, "Station 02+22" is amended to read "Station 102+22".

The Special Provisions are amended to include the following:

SHEAR CONNECTORS

Shear connectors are now to be installed according to OSHA Instruction, Directive No. CPL 2 – 1.34, dated March 22, 2002.

Section 708, Steel Structures, in the 2001 Supplemental Specifications to the Standard Specifications, is amended as follows:

1. Paragraph 24. of Subsection 708.03 is void.
2. Paragraph 3. of Subsection 708.04 is void.
3. Paragraphs 1. and 5. of Subsection 708.05 are void.

The Special Provisions are amended to include the following:

TEMPORARY TRAFFIC CONTROL DEVICES

The last sentence of paragraph 2.b.(i) of Subsection 422.04 in the Supplemental Specifications is void.

Paragraphs 3.b. and 3.c. of Subsection 422.05 are void and superseded by the following:

- b. Vertical panels shall be paid for at ½ the contract unit price for the item “Barricade, Type II”.
- c. “42 inch (1070 mm) Reflectorized Cones”, “Reflectorized Drums”, and “Barricades Type II” shall be paid for at the contract unit price bid for the item “Barricade, Type II”.

On plan sheet 38, the steel sheet piling “Minimum section thickness” is amended to read:

Minimum section thickness.....15.5 mm

Upon execution of the contract, the plans will be revised to reflect this change.
