On page 1 of the Proposal, the following changes are made:

On page 9 of the Special Provisions, in the provision titled TRENCHED WIDENING, paragraph 1.b. is void and superseded by the following:

b. The contractor shall remove existing shoulder material and a portion of the existing bituminous surfacing to expose a vertical face, as shown in the plans, using methods approved by the Engineer. The trench shall be the same depth as the Fly Ash Stabilized Bituminous. The excavated material shall be placed outside of the trench to be used as shouldering material.

The Special Provisions are amended to include the following:

AWARD AND EXECUTION OF CONTRACT

The first sentence of Subsection 103.03 in the Standard Specifications is void and superseded by the following:

The bidder to whom the contract is awarded shall furnish within 5 days after the award, a contract bond, in a sum equal to the full amount of the contract.

The first sentence of Subsection 103.04 is void and superseded by the following:

The contract shall be signed by the successful bidder and returned, together with a satisfactory bond, within 5 days from the date of award.

Paragraph 1.a. of Subsection 103.05 is void and superseded by the following:

a. Fails to file an acceptable performance bond within 5 days from the date of award.
