Work Begins October 6 on Highway 15 South of Fairbury




Work is Scheduled to Begin Soon on Highway 14 South of Clay Center

Nebraskans Asked to "Put the Brakes" on Traffic Fatalities

October 10 is the third annual "Put the Brakes on Fatalities Day." The Nebraska Department of Roads joins national safety organizations as they draw attention to the nation's high rate of traffic fatalities, about 42,000 per year, or 115 fatalities each day – one fatality every 13 minutes. The day is intended to heighten awareness about what can be done to stop fatalities by focusing attention on individual behaviors, with the goal of achieving one day of zero traffic fatalities across the nation.

Last year on October 10, no fatalities were reported on Nebraska's highways, and there were 12 days in October with no fatalities. October 2002 had 31 traffic fatalities, compared to 16 deaths in 2001, and 28 deaths in 2000, with a 2000-2002 average of 25 fatalities for the month of October. The October 2002 fatality number is 94 percent higher than the fatalities reported in October 2001. However, October 2001 had the lowest number of traffic fatalities on record for that month since 1944 in the state of Nebraska.

While there was a decrease in highway fatalities for several years, from 295 in 1999 to 276 in 2000, and 246 in 2001, loss of lives while driving on Nebraska's highways increased at an alarming rate in 2002, with 307 fatalities. This year, by the end of September, 215 people had died in motor vehicle crashes in Nebraska, 14 less than the same time last year – a 6 percent decrease.


Nebraska Department of Roads Director John Craig says, "We want to continue to turn this trend around by drawing attention to the issue and to steps that can be taken to reduce highway fatalities."

Much progress has been made through the development of safer vehicles and specialized safety equipment, such as child seats and helmets. In addition, roadway improvements and driver safety educational programs have helped reduce fatalities.

Following the national theme of "drive as if your life depends on it" people are asked to take an extra measure of care by sharing the road with other users – drivers, pedestrians, motorcycle and bicycle operators and passengers – in a *safe* manner. This can be achieved by the following: drive courteously and defensively; know the rules of the road for your mode of transportation; obey all signs and signals; wear protective gear – seat belts or helmets; don't speed and don't drive aggressively or impaired. 
Traffic will be detoured on a marked route using US-77 and Hickman Spur, S55G.



I-80 Temporary Closure Needed for Interstate Work



The Nebraska Department of Roads will hold a public information meeting regarding relocation of Nebraska Highway 11 and construction of a highway viaduct at Wood River.

The meeting is being held to present preliminary plans of the proposed project and to obtain public input. Personnel from the Department of Roads will make a presentation about the project and receive questions and comments.

The proposed alternative relocates Nebraska 11 around the south side of town and over Union Pacific Railroad tracks and U.S. Highway 30 just west of town. The preferred route ties back into Nebraska 11 on the west side of town near Thirteenth Street.

Construction of a pedestrian bridge over UP tracks is proposed near the center of town. The project is identified as STPD-TMT-11-2(114), also known as *Wood River Viaduct*.

Two road crossings of UP tracks must be removed upon completion of the new viaduct. The proposed closings are the downtown crossing on East Street and the west crossing on 140th Street.

When the new roadway is open to traffic, a segment of Nebraska 11 east of town must be relinquished to Wood River and to Hall County.

About 47 acres of additional land must be purchased as highway right-of-way for the project. One residence and a number of other structures also must be acquired.

Nebraska 11 will remain open to traffic throughout construction. Temporary roadways around work zones will be used during some phases of construction. Construction may impact wetlands areas and mitigation may be required.

Where possible, the Department of Roads will provide an accessible meeting facility for disabled people. Appropriate provisions for people who are hearing and visually challenged will be made if the department is notified by Nov. 12, 2003. 
