



on March 17, 2003, to discuss the next steps in completing a Final Environmental Impact

Statement on the Highway 81, Yankton Meridian Bridge replacement project.

A public hearing was held December 5, 2002, covering information presented in the Draft Environmental Impact Statement, regarding location alternatives for a new structure, as well as alternatives for the existing structure. This issue will need to be resolved prior to preparation of the Final Environmental Impact Statement.


