Temporary I-80 Eastbound Road Closure & Detour at Locust Street Interchange

Interstate 80 eastbound will be closed from Exit 312 to Exit 324 for 7 hours on Wednesday, May 14, at 11:00 p.m. until Thursday, May 15, at 6:00 a.m. Traffic will be detoured on US Highway 34 east to the Giltner Spur. The detour route will be north on US-281 (US-34 east) for 4 ½ miles to the junction of US-34 and Nebraska Highway 2, then east on US-34 for 12 miles to the Giltner Spur, then south 3 ½ miles back to I-80. This closure is due to removal operations of the bridge deck and girders of the existing overhead bridge structure at I-80, Reference Post 314 Locust Street Overhead Bridge.

Interstate 80 westbound will be closed from Exit 318 to Exit 312 for 7 hours on Tuesday, May 20, at 11:00 p.m. until Wednesday, May 21, at 6:00 a.m. Traffic will be detoured on N-2 north for 3 ½ miles to US-34 west. The detour route will follow US-34 west for 6 miles to the junction of US-34 and US-281, then will proceed south on US-281 (US-34 west) for 4 ½ miles back to I-80. The closure is due to removal operations of the bridge deck and girders of the existing overhead bridge structure at I-80, Reference Post 314, Locust Street Overhead Bridge.



I-180 Temporary Closure Needed for Interstate Work

I-180 southbound lanes, in Lincoln, will be closed, temporarily, at Cornhusker Highway on Thursday, May 15, from 9 a.m. to 12 noon. The southbound entrance ramp off Cornhusker will also be closed.

The closure will allow replacement of damaged guardrail on the Oak Creek Bridge.

Both I-180 exits to Cornhusker will remain open. A marked detour will be provided to route traffic east on Cornhusker, then south on 11th Street. Local motorists may wish to consider a different route to downtown. Northbound I-180 travel will not be affected.

Friday, May 16, the northbound I-180 exit ramps to Cornhusker Highway in both directions will be closed from 9 a.m. to 3 p.m. for bridge repair.

Transportation Enhancement and Byway Funding Public Forums to be Held in Western Nebraska

The Nebraska Department of Roads is announcing the availability of funds for the Transportation Enhancement Program and the Byways Program for Fiscal Year 2004. The Transportation Enhancement Select Committee is requesting proposals for projects to build pedestrian/bike trails, restore historic transportation facilities, and landscape or beautify streets and highways. Proposals will also be accepted for funding of projects along Nebraska's nine scenic byways.

Anyone interested in applying should return their Intent-to-Apply form by July 14, and complete the final application form by October 3, 2003.

Work is scheduled to begin on June 16, 2003 on Highway US-75, according to the Nebraska Department of Roads. Work will be from the north edge of Dawson to the N-62 Stella spur, on US-75.

I-180 Temporary Closure Needed for Interstate Work

I-180 southbound lanes, in Lincoln, will be closed, temporarily, at Cornhusker Highway on Monday, June 2, from 9 a.m. to 12 noon. The southbound entrance ramp off Cornhusker will also be closed.

The closure will allow replacement of damaged guardrail on the Oak Creek Bridge.

Traffic on Northbound I-180 will switch from the current two-way traffic to exiting at the Cornhusker exit, detour on the frontage road and re-enter on the entrance ramp. Weather permitting, the traffic change will take place Wednesday, June 4. Traffic will remain in a single lane. This will allow for continued safe construction of the Northbound bridge over Oak Creek.

Work to begin soon on I-80 from Minden to Gibbon

Work is scheduled to begin June 9 on Interstate 80 from just west of the Minden Interchange to about 1 1/2 miles west of the Gibbon Interchange, according to the Nebraska Department of Roads.

Constructors, Inc. of Lincoln has the \$1,473,941 contract for milling, concrete patching, and asphalt surfacing. Traffic will be maintained with lane closures, a 12' width restriction and reduced speed limits. All lanes of traffic will be open from 3 p.m. Friday to sunrise the following Monday. Work is anticipated to be completed in September, 2003. The Department of Roads' project manager assigned to this project is Lyle Kohmetscher of Hastings.
