

Northbound Lanes of Highway 77 to Open From Ceresco to Wahoo

Weather permitting, the northbound lanes of Highway 77 from Ceresco to Highway 92, at Wahoo, will be open to traffic on Friday, August 6, according to the Nebraska Department of Roads. Approaching the junction of Highway 77 and 92, the right-hand lane of Highway 77 will end and traffic will merge to the left. There will be a three-way stop at the junction of Highway 77 and 92, and northbound traffic must turn either right or left onto Highway 92. The speed limit for northbound traffic will be 60 mph with speed zones as necessary.

The left-hand lane of southbound Highway 77 will be closed for installation of pavement markings from the junction of Highway 92 to Ceresco. The speed limit will be posted at 60 mph until this work is completed and then returned to 65 mph.

Lighting at the junction of Highways 77 and 63, and the junction of Highway 77 and 92 will be activated as soon as possible.





Department of Roads to Work with Communities to Resolve Banner Issue

Because of an increasing number of banners being placed on highway right of way within communities, the Department of Roads will develop, in cooperation with the Federal Highway Administration (FHWA) and local communities, written clarification of the federal regulations and state laws regarding encroachments on the right of way.

The Department of Roads and the FHWA have recently been made aware of banners in several cities that contain advertising. In a letter dated August 13, the FHWA reminded the Roads Department that banners containing advertising are not permitted. The FHWA directed the department to have un-permitted banners removed by December 31, 2004 and further advised that violations can jeopardize federal funding for entities involved.

In order to comply with the directive, the Department of Roads will work with communities to update and clarify which types of banners can be permitted on the highway right of way. The department expects to distribute the final clarification document to all communities by the end of November. Communities with non-compliant banners will receive specific notice to that effect. If requested, the department will provide guidance on modification options to bring the banners within compliance.

Encroachments in the right of way are regulated due to the potential for those objects to distract motorists and obscure regulatory signing or other traffic control devices.

The Nebraska Department of Roads along with the State Highway Commission will hold a public hearing regarding relocation of Nebraska Highway 11 and construction of a highway viaduct at Wood River.

The proposed alternative would relocate Nebraska 11 around the south side of Wood River and over Union Pacific Railroad tracks and U.S. Highway 30 just west of town. The preferred route ties back into Nebraska 11 on the west side of town near Thirteenth Street.

Construction of a pedestrian bridge over UP tracks is proposed near the center of town. The project is identified as STPD-TMT-11-2(114), also known as **Wood River Viaduct**.

Two road crossings of UP tracks must be removed upon completion of the new viaduct. The proposed closings are the downtown crossing on East Street and the west crossing on 140th Street.

When the new roadway is open to traffic, some segments of Nebraska 11 must be relinquished to Wood River and to Hall County.

About 37 acres of additional land must be purchased as highway right-of-way for the project. One residence, a number of grain bins and other structures also are directly impacted by the project and must be acquired.

Nebraska 11 will remain open to traffic throughout construction. Tem-

porary roadways around work zones will be used during some phases of construction. Construction may impact wetlands areas and mitigation may be required.

The public hearing is being held to provide information about location features of the proposed roadway. All people are invited to attend and present relevant comments and questions.

Written statements and exhibits may be presented at the hearing, and they will be accepted as part of the public record for 10 days after the hearing.

The public is invited to stop at the hearing location from 6:30 – 7:30 p.m. for an informal discussion of any aspect of the project.

Personnel from the Department of Roads will be available to visit one-on-one about the proposed improvements.

Where possible, the Department of Roads will provide an accessible meeting facility for disabled people.
