

#### Public Hearing January 19 for Hwy. 75 Improvements in Plattsmouth Area

The Nebraska Department of Roads and the State Highway Commission will hold a Public Hearing Wednesday, January 19, regarding reconstruction of U.S. Highway 75 between Murray and Plattsmouth. The hearing will be held at 7:30 p.m., at the Community Center, 625 Avenue A, in Plattsmouth.

The proposed improvement of U.S. 75 involves reconstructing about 7 miles of the two-lane highway into a four-lane expressway. The driving lanes will be separated by a raised median.

Construction will include grading, surfacing, drainage structures, bridges, a railroad viaduct, lighting, and traffic signals where warranted.

The project begins just south of the intersection with Nebraska Highway 1 and ends just south of the Oak Hill/Avenue B intersection in Plattsmouth. Intersecting roads will be reconstructed as part of the project.

U.S. 75 will remain open to traffic during construction. Temporary roads around work zones will be used during some phases of construction.

Private property must be acquired for highway right-of-way throughout the length of the project. Control of access to the highway will be perpetuated.

Construction will impact wetland areas and mitigation will be required for about 1.8 acres. Replacement wetlands will be established along the project or at the Lincoln Bend Bank Site located along the Missouri River near Indian Cave State Park in Nemaha County.

Interested persons are invited to stop at the hearing location from 3:00 to 5:00 p.m., before the hearing, for informal discussions with Department of Roads' personnel on any aspect of the project.

Preliminary plans developed by the Nebraska Department of Roads are available for public inspection at the NDOR District 2 Office, 4425 S. 108<sup>th</sup> Street, in Omaha, and at the Roadway Design Division, 1500 Highway 2, in Lincoln. 



The Nebraska Department of Roads along with the Nebraska Highway Commission will hold a public hearing regarding the replacement for the Meridian Highway Bridge over the Missouri River.

The U.S. Highway 81 project, identified as NH-81-4(113) and known as **Yankton Bridge**, involves reconstructing and widening the highway and constructing a four-lane bridge between Nebraska and South Dakota.

The 2-mile-long project begins just south of the intersection with 2<sup>nd</sup> Avenue in Yankton and ends just south of the intersection with Nebraska Highway 121. Construction will include grading, drainage systems, roadway surfacing, shoulders, lighting, and a 76-foot-wide bridge. The bridge design includes a 16-foot-wide median between the northbound and southbound driving lanes.

Construction will be done under traffic. Temporary roadways around work zones may be used during some phases of construction.

The existing bridge is listed on the National Register of Historic Places and will be maintained for pedestrian use as part of a trail network. The new bridge will be constructed about 900 feet west of the existing bridge. U.S. 81 will be reconstructed on new alignment from just south of 2<sup>nd</sup> Avenue to just north of South Yankton, Neb.

The process of developing an Environmental Impact Statement has been completed for the proposed project.

Acquisition of private property for highway right-of-way will be required throughout the length of the project. One underground water storage tank must be removed at the Yankton treatment plant east of the proposed bridge.

Control of access to U.S. 81 near the new bridge will be acquired. The intersection of Riverside Drive with U.S. 81 in Yankton will be closed.

The public hearing is being held to provide information about design features of the project. All people are invited to attend and present relevant comments and questions.

Written statements and exhibits may be presented at the hearing, and they will be accepted as part of the public record for 10 days after the hearing.

Where possible, the Department of Roads will provide an accessible meeting facility for disabled people. Appropriate provisions for people who are hearing and visually challenged will be made if the department is notified by Jan. 20, 2005. Notification should be submitted to: Public Hearings Officer, Department of Roads, P.O. Box 94759, Lincoln, Nebraska 68509-4759, voice telephone (402) 479-4871. TDD telephone is (402) 479-3834.

The public is invited to stop at the hearing location from 3 - 5 p.m. for an informal discussion of any aspect of the project.



#### Grant Money Available for Transporting Elderly and Persons With Disabilities

The Nebraska Department of Roads has announced funds are now available to private non-profit organizations for transportation needs of elderly persons and persons with disabilities for whom mass transportation services are unavailable, insufficient or inappropriate. **Only private non-profit organizations incorporated within the state are eligible to apply for this assistance.** Public agencies, governmental bodies, and private individuals are not **eligible for this program.** 

The Federal Transit Administration's Section 5310 program is a Federal Capital Grant program that requires a local match and is managed by the Department of Roads. It is designed to provide assistance for the purchase of vehicles and related equipment for transportation needs of elderly and disabled persons.

The Department of Roads is distributing information on this program to private non-profit organizations such as nursing homes and hospitals, as well as coordinating agencies such as area agencies on aging.





The hearing will be held at 7:30 p.m., at the Riverfront Event Center, 121 West 3<sup>rd</sup> Street, in Yankton, South Dakota.

The U.S. Highway 81 project involves reconstructing and widening the highway and constructing a four-lane bridge between Nebraska and South Dakota.

The 2-mile-long project begins just south of the intersection with 2<sup>nd</sup> Avenue in Yankton and ends just south of the intersection with Nebraska Highway 121. Construction will include grading, drainage systems, roadway surfacing, shoulders, lighting, and a 76-foot-wide bridge. The bridge design includes a 16-foot-wide median between the northbound and southbound driving lanes.

Construction will be done under traffic. Temporary roadways around work zones may be used during some phases of construction.

The existing bridge is listed on the National Register of Historic Places and will be maintained for pedestrian use as part of a trail network. The new bridge will be constructed about 900 feet west of the existing bridge. U.S. 81 will be reconstructed on new alignment from just south of 2<sup>nd</sup> Avenue to just north of South Yankton, Nebraska.

Acquisition of private property for highway right-of-way will be required throughout the length of the project. One underground water storage tank must be removed at the Yankton treatment plant east of the proposed bridge.

Control of access to U.S. 81 near the new bridge will be acquired. The intersection of Riverside Drive with U.S. 81 in Yankton will be closed.

Interested persons are invited to stop at the hearing location from 3:00 to 5:00 p.m., before the hearing, for informal discussions with Department of Roads' personnel on any aspect of the project.

Preliminary plans developed by the Nebraska Department of Roads are available for public inspection at the NDOR District 3 Office, 408 N. 13<sup>th</sup> Street, in Norfolk, and at the Roadway Design Division, 1500 Highway 2, in Lincoln.
