

## Building the Team and Disciplining the System

I have coined a phrase that says, "You lead people and manage things and it's all about people. However, if you don't measure it,

you can't manage it. But it's still all about people."

All of us deal every day trying to balance people and other "stuff." It is a delicate balance but reflects that we are a society of people with all our strengths and flaws.

As the Department of Roads and our many partners evolve in our relationships, I thought I should expand a bit on where I am trying to go. As with many things, I will attempt to draw some fine, but important distinctions in this regard.

In my title to this piece, I have started with "Building the Team." That dimension is the piece that really refers to my common phrase that is "all about people." Building the team is all about people. Either we're pulling together or we're not.

Regardless, building the team is all about getting people to work together to do things they could not accomplish individually. A team is like a finely tuned and well-oiled machine that puts out horsepower. We all know when we have belonged to a truly great team and by the same token, we all know when we have been a part of a less than great team. Being a part of a great team is truly a wonderful experience, and I feel that way about the Department of Roads and our extended family of partners.

#### **Fine Distinctions**

Now, for some fine distinctions. We all must distinguish when we are dealing with people and when we are dealing with "things." I have learned that a good rule for dealing with people is to follow the "Golden Rule" which, in effect, is to treat others how you want to be treated. However, "things" do not have feelings, emotions, intellect and the other attributes of people. Things are just dumb and inanimate.

As all of us contribute to building the team, I am also attempting to better manage the "things." Collectively, I call these the "system." The system or systems and subsystems are the data, processes and procedures that collectively allow us to get our work done as efficiently and effectively as possible. For example, we are moving toward closing out construction projects within 60 days of project completion, perhaps through post-construction reviews. We have instituted joint Department-Contractor committees to facilitate better understanding of our work. We are instituting a Department Management Information Systems Steering Committee, which essentially "morphs" the

current IT Cabinet into an oversight, coordination, integration and analysis of data role to optimize the allocation of our resources— Transportation Asset Management. We have instituted constructability reviews, pre-construction, construction and post-construction meetings. We have made business decisions to contract out what saves us money, such as mowing, made strategic investments in equipment, buildings, computers, instituted video conferences, developed a High Plains Coalition, Pioneer Net, and established District and Department Operations Centers. We will continue to review project delivery, etc., etc., all in an effort to improve and get the best results possible from our collective and individual efforts.

#### **Continuous Improvement**

Disciplining the system is quite literally a path towards getting the most out of the "system or things." It is a part of the path towards continuous improvement. So, you ask, why should we "Discipline the System?" There may be other reasons, but I have two. First, we have an obligation to the taxpayer to use their resources (i.e., taxes), as wisely as we can. Second, there are those of us who are simply motivated to be the best we can in spite of our many flaws.

Even though many of the gains from disciplining the system are marginal at best, they are efforts to improve the management of the system or systems, but not to manage the people.

Remember, "You lead people and manage things and it's all about people." By extension, you "Build the Team and Discipline the System." This is a fine but important distinction to remember. •

## Polish Your Communication Skills to Turn Rants into Raves

What's the secret to successfully turning your community's rants into raves?

Quite simply: good communication.

That means being prepared, being a good listener, and having a concise message. And just as you need certain tools and techniques to build roads and highways, you need verbal and nonverbal tools to communicate effectively.

What you say is just as important as how you say it. Research and studies show that your "audience"—whether it's one person or an auditorium filled with a thousand people—perceives you on three levels: body language, voice, and word choice. If your goal is to project confidence and concern, you should use your eye contact, gestures and vocal tone intentionally—they can have a powerful impact.

That approach, coupled with caring words, rather than "generic speak" or statistics, will garner a more positive response. Jargon or empty rhetoric only fans the flame of fierce opposition. For example, when faced with a parent who fears the effects of additional traffic in a neighborhood, no amount of studies will trump raw emotion. So what's the key? Being prepared.

Anticipate resistance so that you can formulate a message in advance. Expecting to wing it while under pressure will leave you grounded. Strategies that offer reassurance, empathy, and action can make all the difference in a heated community meeting. Put yourself in the other person's position and think of what might tackle the problem...perhaps announcing a new "traffic-buster" program, community beautification project, or outreach program at a school.

Much as a road curves around obstacles to reach a destination, oft-times the indirect approach, rather than straight facts and figures, will help you reach your goal. Now, because you are an expert in the highway industry, your instinct is probably to tell your audience everything you know...but don't! Because it's a fact, the more you talk, the less people remember. Especially in a tense situation, less is most definitely more.

How best to craft your message to grab the attention of your audience? Tune to the radio station everyone wants to be tuned to: WII-FM... "What's In It For Me?" Approaching a challenging situation from another person's perspective will help create positive results. In fact, NAPA member Pete Alex's use of effective communication reaped benefits for his company AND community when facing complaints from neighbors. He found that being a good neighbor meant good business. One of his city's development executives put it this way: "When you have communication you have understanding. When you have understanding, then you can have some acceptance."

The following provides a road map to help *you* chart a successful communication course:

#### **Emotional vs. Factual**

Since we are over-saturated with information, be it TV, radio, e-mail, voice mail or even junk mail, people respond better to information presented in an emotional versus factual way. So instead of creating

MEGO (My Eyes Glaze Over) by reeling off statistics, make people relate to something. To wit, if you use imagery that conjures up feelings of empathy, joy, sadness, or "oh, wow, I didn't know that" or "gee, that could be me," etc., it will help to cut the clutter. For example, you can empathize with a concerned mom or dad by revealing that you too are a parent, and underscore your concern in formulating a remedy for a particular situation.

#### **Props and Visuals**

It is a fact...people remember what they see three times longer than what they hear. If they can touch it, the retention is about 10 times more. Therefore, by brainstorming with your team to hatch ideas that will illustrate your point, you will maximize your message. For example, you might bring in a household vacuum cleaner to demonstrate how a baghouse acts as a filter to trap dust particles much as a vacuum cleaner does at home.

#### **Message Tools**

To build a solid message, you need special tools. There are several that you can use to make your presentation resonate. You might use examples or anecdotes to illustrate a key point. Another option is using words that emphasize action. So, rather than "beginning" the process, perhaps you are "jumpstarting" or "launching" a new plan. Since people tend to remember information that is presented in a rhythmic pattern, alliteration can be effective. A member of Congress once described the benefits of a new bill thus: "It will provide freedom, flexibility, and funding for families," and then elaborated.

#### Be a "Pro" at "Con"flict

When facing confrontation, there are basically two approaches—defuse or escalate. Dealing with an irate

community member is upsetting, but there is an effective way to defuse or de-escalate the encounter. Calmly demonstrate and reassure the person that they have been heard. At the core, that is what most people want. Especially if someone is impassioned, you will see positive results once they feel understood. You do not necessarily have to agree, but you do have to prove that they have been heard. So, to cross those choppy waters, you must build a bridge.

#### Build a Bridge...Not a Wall

There are ways to disagree with a person, yet not be disagreeable. You may say something and unwittingly produce a wall; say it another way and build a bridge. To elicit a positive response, you must prepare for conflict and then practice how to defuse it. So what's the key? Have some

"bridge" phrases ready. Here are some examples to take out for a test drive, either at home or at work, before your next community encounter:

- Let me make sure I understand...
- What I hear you saying is...
- Here's another way of looking at it...
- Please let me put that in perspective...
- Let's review what's just been said...

These are suggested bridge phrases—you can certainly create your own—but the point is to verify that you understand.

The next step is to confirm next steps. Make a plan to contact the person or their organization by a certain time and stick to it. That action alone will engender good will. Remember, it is about verbal and nonverbal communication, as well as perception versus reality. If your objective is to change a negative

perception into a positive reality, this will put you on the road to success.

These tactics and techniques will help ratchet up your performance as a consummate communicator, but they are only part of your business arsenal. Combined with community initiatives and common sense, this is a winning formula. Remember, sometimes you can do the right thing and not have the desired result. But at other times, you will see that solid communication can give you an incredible boost. Use these tools to navigate a new and powerful communication route. Who knows, you just might create the right communication mix for your company or agency!

There are two new formal awards:

- ➤ Employee & Manager of the Year Runner-Up - choice of \$100 monetary award (before taxes), or gift certificate to Nebraska business of choice, and framed certificate.
- ➤ Director's Award wood plaque with image of Sower, including engraved brass nameplate. District Engineers, Division Heads, Deputy Directors are eligible for this award.

Two informal awards were added:

- "I Got Caught" stickers denoting "I Got Caught" for on-the-spot recognition used by all levels of employees.
- ➤ Orange Cone stationery for handwritten appreciation used by all levels of employees.

Additional things to look for in the near future: an updated Human Resources website with revised nomination forms available to download, satellite/agency panel training for all the districts and central headquarters, and updated posters describing the available awards.

## **District Maintenance Safety Awards Presented**

The 2002 District Maintenance "Safe Worker" and "Safe Driver" Awards were presented to the district winners at the NDOR Maintenance Conference in Kearney May 6th. Roger Klasna, District 6 Maintenance Superintendent, and Tom Shepardson, NDOR Safety Coordinator, made the presentations.

District 7 received the "Safe Worker Award" and "Safe Driver Award." Larry Peterson, District Maintenance Superintendent, accepted the awards. To earn the "safe worker" honor, the district's incident rate was approximately three times better than the overall Maintenance Incident Rate average. To achieve the "safe driver" honor, the district had the lowest vehicle incident rate in 2002, which was  $2\frac{1}{2}$  times better than the maintenance average.

District 2 was the winner of the "Most Improved Safe Worker Award," which was accepted by District Maintenance Superintendent Dale Butler and Deputy Director-Engineering John Jacobsen (former District 2 Engineer). Their incident rate was 3 times better than their 2001 performance.

District 1 earned the "Most Improved Safe Driver Award." Roger Kalkwarf, District Maintenance Superintendent, accepted the award. They improved the vehicle accident frequency rate more than any other district in 2002 over the year 2001. ◆

### **District 6 Appreciation Award**

Gary Britton, Assistant Manager in the Right-of-Way Division, received a District 6 Appreciation Award at the quarterly Rewards and Recognition ceremony held recently at Central Headquarters in Lincoln.

Les O'Donnell, District 6 Engineer, made the presentation. The award recognized Britton's efforts as part of a District Unit Improvement Team (DUIT) organized three years ago to remove non-permitted encroachments on the highway right-of-way. ## New NDOR Facility to Help Maintain Area

A satellite shop off the Ogallala shop for the Nebraska Department of Roads is operational following the completion of the project in November 2002.

The project included a combination office and shop building and a storage building, located in the northwest quadrant of the Interstate 80 interchange at Big Springs.

The office and shop building provides facilities to work on equipment as well as store the equipment housed at the location.

The main portion of the storage building holds 1,800 tons of salt for use on highways and the interstate. Other chemicals used for highway maintenance are stored in the wings of the building.

Simon Contractors & Subsidiaries of Cheyenne, Wyo., constructed the facilities at a contract cost of nearly \$1.1 million. Funding for the project came from the State of Nebraska. The contract was let July 19, 2001.

Highway supervisor at the new facility is Bob Hilton. Matt Radke is crew chief at the Big Springs shop. The five employees at the facility include the supervisor, a mechanic and three maintenance employees. Employees at the new facility were transferred from the Ogallala shop. Layne Childers, highway super-

intendent from the Ogalalla Department of Roads office, also covers Big Springs facilities.

According to Les O'Donnell, Nebraska Department of Roads district engineer, "The Big Springs Maintenance facility will allow the Department of Roads' forces to have better response to the big interchange at Interstates 80 and 76 and all other highway needs in the Big Springs area."

"The construction of this facility in Big Springs is an indication of the importance that the Nebraska Department of Roads places on the need of timely public service and emergency response to the traveling public," O'Donnell said.

"The I-80 system seems to be a corridor of choice for the trucking industry and tourists. The average daily traffic on the Interstate 80 system continues to increase," O'Donnell said.

Previously, maintenance employees from the Ogallala facility responded to the Interstates 80 and 76 interchange, also known to truckers as the split. The distance between Ogallala and the

80-76 interchange caused the response time to be less than satisfactory in bad weather. With the Big Springs facility, crews and equipment are more readily accessible when the need arises, O'Donnell said.

Currently, employees at the Big Springs facility are hauling base material for an upcoming construction project, which will include pavement reconstruction from the interchange to the Bosselman Truck Plaza and Total Petroleum driveways, south of Big Springs. •

## Highway Safety Summit Identifies Strategies to Save Lives

Nearly 100 people from emergency, engineering, enforcement and educational organizations attended the 2003 Highway Safety Summit, held March 19 at the Cornhusker Hotel. The Nebraska Department of Roads (NDOR) and the Federal Highway Administration (FHWA) hosted the event.

A wide variety of individuals and organizations addressed four major topics and identified strategies to save lives and reduce traffic crashes. The topics discussed were: Red Light Running/Intersection Safety; Older/Younger Drivers; Alcohol/Fatigue/Impaired Driving; and Speeding.

The morning session included speakers from the Mid-America Transportation Center (MATC) at UNL and Mothers Against Drunk Driving (MADD) on other highway safety-related issues. For the afternoon session, attendees were divided into four breakout groups to discuss the four major topics.

Progress of the four action groups will be monitored and a follow-up Safety Summit may be held sometime within the next two years. The Alcohol/Fatigue/Impaired Driving action group has applied for a grant and is making plans for a future Alcohol/Impaired Driving Summit. ◆

## Have You Checked Your DOR-OI's Lately?

They have been around for quite some time, but many NDOR employees may not be aware of exactly what Department of Roads Operating Instructions (DOR-OI's) are and where they may be found. Their primary purpose is to convey department policy on subjects not covered by other directives, existing manuals or publications.

Subjects addressed by DOR-OI's include: DOR-OI Policy; Legislative; Communication; Dues, History, and Rules; Travel, Vehicle, and Aircraft Use; Manpower; Archives and Central Files; Agreements, Audits, Contracts, Financial, Railroads, and Utilities; Data Processing;

Legal, Theft, and Vandalism; Corridors, Engineering, Planning, Research, and Right-of-Way; Central Headquarters; Capital Facilities, Purchasing, and Supply.

Accessible through the Intranet on NDOR's web page, DOR-OI's are periodically reviewed by the office of primary responsibility (OPR) and revised if needed. When a DOR-OI is revised, significant changes are annotated with a triple asterisk preceding the paragraph number, allowing the reader to quickly locate the newest information.

Since it is required that DOR-OI's be reviewed and updated at least every four

years, many have recently been updated and others will be reviewed in the near future. Requests to create, revise or rescind a DOR-OI should be submitted to Greg Sattler in the Audit Section of the Controller Division for processing. Offices proposing new DOR-OI's or revisions to existing DOR-OI's must submit them exactly the way they want the information presented, as the Audit Section will not compose the draft.

## 20 Things You Can Do to Stay Upbeat in Down Times

- **8. Train your people.** During slow periods, your people may have the time to upgrade their skills. Use the time productively for formal training.
- **9. Promote continuous learning.** Encourage employees to read, to

- seek education on their own, to boost skills through self-paced CDs, and to become involved in their own professional organizations.
- 10. Foster teamwork. Now is the time to *involve* the people around you in solving problems. Sound communication, group-based tasks and goals, and employee empowerment can bring newfound commitment to the work at hand.
- **11. Build atmosphere.** Maintain an upbeat spirit. Play music. Hold pizza or ice cream breaks to boost morale.

## Take Precautions Against West Nile Virus



Last summer West Nile virus was reported in 39 states involving 4,000 reported cases. Of these, 274 victims died and many others were left with permanent disabilities. It is estimated that 80 percent of people infected with the virus have no symptoms and never know they've had it.

West Nile virus was first detected in

the U.S. in 1999. The virus involves mosquitoes and birds. The mosquitoes become infected when they feed on infected birds. The mosquitoes then can transmit the virus to humans and animals from their bite.

Symptoms of West Nile disease can range anywhere from mild—fever, headache and body aches—to severe. On rare occasions (1 percent), people infected with the

virus may develop more severe symptoms such as high fever, neck stiffness, convulsions, muscle weakness, paralysis, and death. The population most at risk is the elderly and those whose immune system is suppressed.

Just like Severe Acute Respiratory Syndrome (SARS) infection, West Nile virus has been getting lots of attention from the public. Compare the annual deaths from West Nile disease (274) to Americans that die from heart disease (500,000) and this really isn't a big issue. But you don't want to be *the* one to die from West Nile disease, so here are some prevention tips:

- ➤ Apply insect repellent containing DEET (N,N-diethyl-meta-toluamide) to exposed skin when you are outside. (DEET does not kill the mosquito, it just makes it harder for them to locate you.) Carefully read the labels for proper application. The higher concentration of DEET provides longer protection, so use appropriately. For more information on DEET call the National Pesticide Information Center toll-free at 1-800-858-7378.
- ➤ If possible, wear long sleeves and pants.
- ➤ Take extra care from dusk to dawn, since these are the peak mosquito-biting times. Avoid the outdoors at these times if possible, and if you must be outside, use the above precautions.

Hopefully your summer will be safe and mosquito-free.

## TURF & GARDEN

## Extra Care Now Reaps Rewards

**Turf -** What a turnaround in May—rain and some more rain. Watch out for fungus when the hot weather breaks. The surplus moisture and heat make a good combination for fungus to develop. Mid-June is time to apply your insecticide for grubs, either Merit or Mach II. As the weather warms up, you can raise your mowing height to 3 inches or more. Keep the blade sharp and keep the water flowing as best you can – 1½ inches per week should do it.

**Trees -** There is still time to plant trees and shrubs. Container or "balled and burlap" is the choice now. It's getting too late for bare root material. If you have a Scotch pine that dies suddenly and the needles do not fall off, you need to have that tree removed at once. The vascular system has probably been plugged by nematodes. Beetles that are now host specific for Scotch pine spread the nematodes. Cutting, chipping or burning will help control the spread of this fatal malady.

**Garden -** Is there a shrub rose in your future? Try one called "Knock Out" by the Conard-Plye Co. It has florescent cherry red blossoms all summer, and the old flowers fall off without you doing anything. It is billed as a self-cleaning rose. A new floribunda rose called "Honey

Perfume" by Jackson & Perkins will be out next year. A new tea rose, "Memorial Day" by Weeks Rose Co., also will be offered in 2004. Your tomato plants need an even supply of water to avoid "blossom-end-rot." Liquid calcium will help prevent this disease, too. Good gardening!

West Nile Virus - You can help yourself and your pets by inspecting your property for any standing water that could be used for mosquito breeding. If the water cannot be drained or if it is a water planting, you can place some mosquito-specific pesticide in the water. Check with your local garden store for this material. It comes as a granule to sprinkle in the water or a floating disk to put in your water planting. I have used the floating disk in a rainwater barrel, and it really works! If the area is too large for this kind of treatment, you can go to the bait shop and buy some minnows to put in the water. I have used minnows and goldfish in the stock tank to keep the mosquito larvae under control. Change the water in your birdbath frequently. The birds will love it, and who cares what the mosquitoes think? The control material will not harm pets that drink from your water gardens.

Weather Stuff - "From the weather calendar:" In the span of geologic time we are but a small speck on the time clock. Was the earth ever an "ice ball?" There is evidence that between 580 and 750 million years ago the entire planet froze into a solid block of ice as many as four times. It took episodes of volcanic eruptions releasing massive amounts of carbon dioxide to cause enough global warming to thaw the planet. There is also evidence that in the past 110,000 years there have been at least 24 major planet wide climate shifts. More notable is the fact that these climate swings can easily occur in a single person's lifetime. Are we warming up or cooling down? Only time will tell, but whatever happens, it has happened before. Those plants and animals that can adapt already have, and they will survive.

## Trash-Off Volunteers Make a Difference

A statewide 1,335-group environmental force has significantly reduced the amount of litter along state highways. One member of the Brothers Not Forgotten group shared his thoughts after the Great Nebraska Trash-Off held in April, "I just don't understand why people toss their trash out the window when so many businesses provide trash cans." This particular group filled 30 trash bags with litter from their adopted section along Highway 77, just south of Lincoln.

This year's Trash-Off participants included 428 Adopt-a-Highway groups, composed of an estimated 5,552 volunteers. These dedicated citizens picked up litter along approximately 1,800 miles of right-of-way, happy to do their part in keeping Nebraska roadsides litter free.

The Adopt-a-Highway program establishes a partnership between Nebraska citizens and the Nebraska Department of Roads, and has proven effective in maintaining clean and attractive roadsides throughout our State.
